- 15 March 1999 Melissa did not report to the court hearing on this day for a battery hearing against Christopher. [Jarion Shephard]
- February/March 1999* Christopher says he last saw
 Melissa looking rough, he
 took her to Taco bell and was
 boarding the train Martyr
 Station. [Alton Calhoun]
- 29 April 1999 Head was found at Avon Avenue -[George McEachern, Tina Millar]
- <u>February 1999</u> Christopher Wolfenbarger was fired from Action Glass for vandalism on one of their vehicles, he never returned the saw he borrowed - [Ronald Brock, Cynthia Brock]
- 3 June 1999 Other remains were found e.g the leg and Skull was analysed and determined to be belonging to a male. [Alton Calhoun, Mary Hauptie]

- 30 December 2001 Melissa's dental records were inputted into the system to aide in locating Melissa.

14 March 2003 - Detective Calhoun canvasses the neighbourhood campus. [Alton Calhoun]

18 March 2003 - Christopher is interviewed the second time by Pete. [Pete Ricketts]

18 March 2003 - Norma Patton was swabbed by medical examiner. [Carol Terry]

was excluded.

February 2023 - Christopher was interviewed a third time by investigators. [Jarion Shephard]
