Theory of the case:

Ana Walshe was working at Washington DC and Brian was looking for Ana Walshe saying that Ana had gone to work and had never returned.

Brian Walshe repeats on the call to Ana's boss that Ana left to go to work on 1st January 2022 and she hasn't come home. He reports to the police on 4th January 2023 that Ana had gone missing.

Ana had got her dream job which paid more in Washington and had moved to DC, she commuted back and forth but wanted her family to join her.

Last person to see Ana was Jen Bloom with her on Wednesday [29th December 2022] at 1:30pm and no one else has seen her since.

 - i. Harrison Schmidt testifies to going to the Walshe residence at 6:30pm
 - ii. Harrison Schmidt testifies to the audio of the interview with Walshe and its played to the jury. [2:50:30]
 1. Brian Walshe is heard on audio saying that when she came back she wasn't feeling well.
 2. Brian Walshe is heard on audio saying that her imessage is showing up on his phone; people calling thinking they saw some action on Ana's facebook and he says that he has access to Ana's instagram.
 3. Brian Walshe is heard on audio saying she has never left the phone at the house but it has happened
 - a. He says that Ana would never turn the phone off.
 4. Brian Walshe is heard on audio saying that Ana would never hide things from him.
 5. Brian Walshe is heard on audio saying that most of his clothing is in DC.
 - iii. Harrison Schmidt testifies to the pictures collected of Brian Walshe's house including entrances, exits, fences, backyard etc.
 - iv. Harrison Schmidt testifies to searching through cell phone data. [4:00:50]
 - v. Harrison Schmidt testifies to meeting up with Trooper Diccico and Bukhenik and reviewed the audio.
 - vi. Harrison Schmidt testifies to an audio recording made at the 2nd interview with Brian Walshe on the 5th January 2023 and the audio is played for the jury. [4:06:40]
 1. Brian Walshe is heard on audio saying that he didn't have his phone that day.
 - a. He says that he got his phone back Monday at 2:33pm
 2. Brian Walshe is heard on audio saying that Peter Kirby went to gym with Ana.
 3. Brian Walshe is heard on audio saying that both Ana and him have never had a physical altercation, arguments or problems. [5:42:20]
 4. Brian Walshe is heard on audio saying he loves his wife and they never had a physical fight and the only issue is being separated.
 - vii. Harrison Schmidt testifies that the fainting talking were detectives interviewing Walshe's mother
 - viii. Harrison Schmidt testifies to Brian Walshe asking him if he should get PR and talk to media and Schmidt told him that he can talk to the media if he wants to, he wouldn't advice it.
 - ix. Harrison Schmidt testifies to audio interview on the 7th January 2023 with Trooper Diccico, Trooper Proctor and the audio was played for the jury.
 1. Brian Walshe is heard on audio saying that he received a wave of messages regarding Ana on Monday and people were telling her to call her but not to embarrass her at work...
 - a. He says that he called Ana's workplace on Wednesday enquiring about Ana.
 2. Brian Walshe is heard on audio saying that he doesn't know how to use the GPS on his Volvo.
